# Casebook on Al and Gender Empowerment Submission Guidelines

## 1. Context

Artificial Intelligence (AI) is reshaping global development, yet the majority of documented innovation originates from high-income countries. In contrast, the Global South hosts a growing wave of inclusive, context-driven AI solutions that tackle gender inequalities - from improving access to healthcare and finance to addressing gender-based violence and climate resilience. To highlight these transformative solutions and to strengthen India's leadership in ethical and inclusive AI, Ministry of Electronics and Information Technology is collaborating with UN Women in producing a Casebook on AI and Gender Empowerment "Top AI Solutions from the Global South."

The casebook will capture and amplify best practices from across regions, positioning India and MeitY as key champions of AI through a gender lens.

# 2. Objectives

- Showcase successful, real-world AI applications that demonstrate measurable gender impact, ethical design, and replicability.
- Develop a digitally accessible and gender-responsive compendium documenting exemplary AI solutions from the Global South.
- Facilitate cross-sector and cross-country learning among AI innovators, policymakers, and regulators regarding gender-inclusive practices.
- Strengthen gender-inclusive AI policy and innovation ecosystems globally.

# 3. Eligibility

The call for nominations is open to all researchers, innovators, practitioners, and experts with successful, scalable, and impactful AI use cases from around the world, particularly focusing on solutions that address systemic gender inequalities within emerging and developing economies (The Global South).

## 4. Call for Abstracts Process Details:

Applicants are invited to submit concise chapter abstracts (maximum 200 words) on Gender-transformative AI use cases that have been successfully deployed within systems across the Global South. Abstracts will be jointly reviewed by **UN Women India and MeitY/IndiaAI** for relevance, quality, and alignment with the Compendium's goals. Selected contributors will be invited to submit full chapters within the allotted time period for writing.

#### 5. Submission Guidelines:

#### a. Abstract Guidelines

- Abstracts (Summary) Maximum 200 words to be submitted
- Authors are requested to prepare the abstracts following the guidelines below:
  - o Length Maximum 200 words
  - Single paragraph, no subheadings.
  - Content Structure The abstract should briefly address the following components:
    - Background/Context: Introduce the topic and highlight its importance or relevance.
    - Objective/Purpose: Clearly state the aim(s) of the chapter.
    - Methods/Approach (if applicable): Summarize the methodology, conceptual framework, or approach taken.
    - Key Findings/Discussion Points: Present the main arguments, insights, or results.
    - Conclusion/Implications: Highlight the significance of the chapter, its contribution to the field, and possible applications.

# b. Chapter Format (for selected contributors):









Each submitted abstract shall go through an evaluation process, and selected contributors shall be invited to submit a complete chapter as per below guidelines:

# Each chapter should include:

- Abstract : A concise summary of the chapter's content.
- Background and Context: Provide the necessary context for the AI use case, including the problem it aims to solve
- Al Use Case Description: This section should detail the solution and its implementation.
  - Solution Description: Clearly explain how AI is used.
  - Deployment & Implementation: Describe the strategy for developing deploying the solution.
  - Scale of Deployment: Quantify the scope of its implementation.
  - Identified Users: Specify who the end-users are.
  - Impact: Describe the results or benefits achieved.
  - Ethics & Governance: Specify any ethical considerations or governance issues associated with the solution.

#### Discussion:

- Successes: Highlight what worked well.
- Challenges: Discuss the obstacles encountered.
- Lessons Learned: Explain the key insights gained from the project relevant for potential adaptors and developers

## Conclusion

#### **Chapter Guidelines:**

- Length: 750-1000 words (max) (~3-4 pages)
- References: APA style, provided as end notes
- Focus on real-world deployment
- Avoid general discussions on AI or epidemiological trends-keep it practical and context-specific.

- Abstracts Screening and Contributor Selection: By 25th December, 2025
